

Ordinance No. 33/2020
of the Rector of the University of Opole
of 3 April 2020

on the amendment of ordinance No. 44/2018 of the Rector of the University of Opole regarding a monthly fee for a place in student and guest rooms in the Residence Halls of the University of Opole.

Based on Article 23(1, 2/2) of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2020, item 85 with further amendments), § 24(1) of the Regulations of benefits for students of the University of Opole introduced as an attachment to the Ordinance No. 41/2019 of the Rector of the University of Opole regarding Regulations of benefits for students of the University of Opole I order as follows:

§ 1

Ordinance No. 44/2018 of the Rector of the University of Opole of 27 August 2018 regarding a monthly fee for a place in student and guest rooms in the Residence Halls of the University of Opole is amended as follows:

1. after § 5a, § 5b is inserted, which reads as follows:

§ 5b

1. Due to limitation of university operations related to the prevention and fight against COVID-19, residents of Residence Halls of the University of Opole, **who in the period from 1 April 2020 to 30 April 2020 will not occupy a place in the Residence Halls** may apply for **reduction in fees** for residence at the Residence Halls of the Opole University.
2. An application form for reduction in fees for living in a student dormitory is attached to this ordinance.
3. The reduced fee for accommodation at the Residence Halls of the University of Opole is **180 PLN per month**.
4. The application should be **sent within 14 days** of the entry into force of this ordinance by electronic means of communication [email] in the form of a **scan signed by a resident** of the Residence Halls of the University of Opole **to the address rektorat@uni.opole.pl**.

Residents of the Residence Halls who are students of the University of Opole are **obliged to submit the application via University mail <@uni.opole.pl>**.

§ 2

Other provisions of the Ordinance 44/2018 of the Rector of the University of Opole of 27 August 2018 regarding the monthly fee for a place in student and guest rooms at the Residence Halls of the University of Opole remain unchanged.

§ 3

The order enters into force on the day of signing with effect from 1 April 2020.
