Resolution no 7/202 of the Chancellor of the University of Opole of 22 of May 2020

On the return of students, PhD students and other persons to Student Dormitories of the University of Opole and principles of accommodation of new persons.

On the basis of Art. 15 Act 2 of Organizational Regulations of the University of Opole (Resolution no 47/2019 of the Rector of the University of Opole of 30 September 2019), it is hereby ordered:

§ 1

In reference to Ordinance no 50/2020 of the Rector of the University of Opole of 19 of May 2020 on changes in the organization of functioning of the University of Opole and in order to increase safety and health prevention of persons living in Student Dormitories, following guidelines regarding return of students and postgraduates to Dormitories are ordered:

- 1. Students and undergraduates who return to continue study at the University of Opole and who live in Student Dormitories, shall be accommodated on the basis of current rules: in order to be accommodated again, they have to inform Dormitory Administration and fill in the questionnaire, according to the pattern which is attached to this Resolution.
- 2. All new persons who want to be accommodated in one of the Student Dormitories will be accommodated, whenever possible, in separate rooms with sanitary units (does not apply to people in relationships, who run a household together).
- 3. Persons from European Union do not have to be in two weeks quarantine, however, persons outside European Union, who want to be accommodated in Student Dormitory have to submit certificate proving that they do not suffer from COVID-19 (negative test result).
- 4. Persons who are living in Student Dormitory have to follow rules regarding restrictions on limits of people who are present in a particular area at the same time.
- 5. Persons who are not accommodated in the Student Dormitory are forbidden to stay there.
- 6. All people living in Student Dormitory have to follow sanitary rules (hand disinfection before one enters a building/room, wearing masks outside Student Dormitories, ban on the organization of mass events).

§ 2

The resolution shall come into force from 25 of May 2020.
